License-based EHR Contract	A CyberMed contractual agreement wherein a CyberMed Software license fee is agreed upon.	A one-time set up fee with a supplemental monthly subscription fee support and maintenance fee. Implementation fees, such as travel and airfare costs, are billed separately. Support and maintenance may require a one-time set-up cost and/or recurring costs.	A contractual agreement is required, as an acceptance of terms and conditions.	All providers must have an active license in order to use the software. Must have internet access.
Electronic Prescribing	Enables a user to perform the following prescription-related electronic transactions: new prescription, change prescriptions, cancel prescriptions Refill prescriptions, request and receive medication history information	Costs are not included as part of the EHR services, although they are mentioned in the contract. if Electronic Prescribing of Controlled Substances is wanted, an additional cost per provider per year is added. API	CyberMed as an application programming interface designed to support development and deployment of applications by our customers or third parties to securely access protected health information.	A cost may be incurred to configure and support real-time access of patient data via the API. This may include a one-time cost for configuration, and an ongoing cost for support, which may have a fixed and a variable component (based on volume of access).	CyberMed may require a contractual arrangement for connecting to systems containing Protected Health Information, in order to allow security and control according to HIPAA rules.	No registration is required for access to API documentation. CyberMed may require developers to obtain a unique identifier for their applications wishing to access PHI. the course of using the capability. Granting individual user access for applications is the responsibility of the CyberMed customer.

Interfaces	CyberMed supports a variety of interfaces to other health information technology including systems for Orders, Results, Procedures, Charges, Images. Text, Lab Information Systems (LIS), Picture Archiving and Communications Systems (PACS).	Custom interfaces may incur a one- time implementation cost and ongoing annual support cost. Interfaces to laboratory devices may require licensing of additional lab device software from a third party. Customization of standard reporting interfaces for public health reporting to meet state or local requirements may incur additional cost.	Establishment of interfaces may require contractual arrangements with suppliers of other HIT systems to which interfaces connect.	Documentation for configuration and deployment of CyberMed's certified interfaces for syndromic surveillance, immunizations and lab reporting are provided so customers can do the configuration, or CyberMed can be contracted.
Data Export	CyberMed provides the ability to export data at a given time or on a recurring schedule, for selected patients or all patients, for specific encounters or a date range.	There is no fee for the use of the data export or health care survey functions. A customer seeking to export large quantities of data may incur costs for specialized support if they require export of data in formats other than the standard CCDA formats supported by CyberMed.	Customer assumes responsibility to protect patient privacy and security for exported data.	No programming is needed for customers to set up one-time data exports. Recurring exports may need some assistance.
Patient Portal	CyberMed provides convenient access to patients for viewing of their health records.	There is no fee to the patient or the clinic. If specialized training is required, there may be a fee.		Patients must be informed of the portal and sign up for an account.
Insurance Verification	Provides access to 3 <sup>rd</sup> party verifier.	There is a separate enrollment fee per provider utilizing the service.		
E-Fax	Provide access to 3 <sup>rd</sup> party E-Fax provider.	There is a separate enrollment fee per provider utilizing the service.
